MR GLADWYN WHITE LETTER.

The White Letter must be understood within a specific context:

Notwithstanding his protest as not a bitter person for not being elected as a Vice President by his colleagues, his approach and utterances betray his claim. He is bitter.

Let us be clear from Mr Gladwin White's rejection by his colleagues for the position of Vice President, on the 17 September 2022 with a wide margin.

- B Bailey 23 votes
- A Tsichlas 23 votes
- L Zwane 18 votes
- G White 8 votes left him bitter

Like Ms Ria Ledwaba and Mr Solly Mohlabeng, he swore that he will fight this democratic outcome.

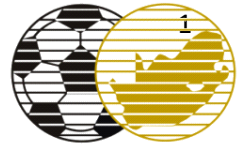
There is no evidence to prove that his position has not changed dramatically since this humiliation. In the 10 years prior there is no letter sent to the regions on any SAFA Member, no engagement with the regions, all this happened after 17 September 2022. Mr White as Vice President of the NEC meeting of 02 October 2021:

- White was present as VP is listed on Page 4 of 23.
- Vice President White was happy with the decision as follows: Page 19 of 23 "The CFO tabled a request for the approval to submit a loan application for the Emergency relief funding to FIFA (FIFA made the loans available because of the impact of Covid on National Associations).
- The maximum amount is USD 5million and the minimum amount is USD 500,000. The CFO submitted the request to the NEC to approve (White was present) a FIFA loan for USD 1.5 million.

The proposed payment as follows:

- 2022 First Instalment
- 2022 Second Instalment
- 2023 Third Instalment
- 2023 Fourth Instalment
- 2024 Fifth Instalment
- 2024 Sixth Instalment

The NEC unanimously approved the proposal as reported by the CFO upon a proposal moved by T Modipa and Seconded by M Fina. Mr White was a participant as VP.

After he lost the election of the VP position on the 17 September 2022, achieving only 8 votes his understanding changed.

“The President must tell the Regions what happened to the last tranches ....., The proposal as recorded was a proposal of the CFO. The CEO is the accounting officer not the President.

The members are entitled to any financial information. The Finance Committee, the CEO and CFO will provide the answers. He is misdirecting the members. His fear is that if we recognise it for what it is Bitterness, it will expose the true intentions of his correspondence.

We reiterate Mr Gladwin White, Ms Ria Ledwaba, Mr Solly Mohlabeng are disgruntled losers, bitter seeking revenge.

The fact that he is raising “a looming fourth term “emphasises the point: “it is about the election. So, whatever he raises — remember it is about the elections. The next election is in 2026.

We are focussing on football matters:

- Banyana in the Olympic qualifiers
- Bafana in the 2026 FIFA World Cup qualifiers
- Banyana with a focus on defending their title “CAF African Champions “
- Our youth program, schools’ program
- Going to CAF playoffs as schools Champions, after emerging as Cosafa Champions
- Youth National teams,
- Coach education,
- Academies
- Referees’ development
- Women football and many other football related urgent priorities.

None of these important football matters is of concern to him, Ms Ria Ledwaba, and Mr Solly Mohlabeng. They never raise these as important matters.

SAFA is focused on these football matters even if it is regarded as trivial by them.

LEGACY TRUST. This matter was discussed in the NEC-meeting on the 2 October 2021. On page 4 of 23 Mr Gladwin white is listed as in attendance as a Vice President.

The following were reported to the NEC:

- The Legacy Trust had entered into a dissolution state.
- The contracts of all staff members with the exception of the General Manager had been terminated.
- The General manager with the support of the ENS Africa (Legal) and EY Financial Platform would conclude the formal dissolution of the Trust.
- The final allocation of the grants was decided upon at the Board of Trustees meeting held on 16 April 2021 and would be disbursed in accordance with the decision of the Board Meeting
- ENSAfrica outlined the requirements for the dissolution of the Trust highlighting the following:

1. All contracts with service provided must be terminated.
  2. The donor (FIFA) must give consent for the dissolution of the Trust. The consent letter has been completed.
  3. FIFA and SAFA would decide on the remaining Trustees that would oversee the final dissolution of the 2010 FIFA World Cup Legacy Trust upon lodging of application for the deregistration of the 2010 FIFA World Cup Legacy Trust with the Master of the High Court.
  4. The 2020 FIFA World Cup Legacy Trust must make provision for the cost of dissolving the 2010 FIFA World Cup Legacy Trust and distribute the whole of the Trust Fund (including undistributed income still in their possession) to any public benefit organisation.
- EY will support the General Manager to conclude all financial obligations to arrive at the complete deregistration of the Trust. This will include:
    1. Proceed to, out of the assets of the 2010 FIFA World Cup Legacy Trust, pay, satisfy and discharge of all the debts and liabilities of the 2010 FIFA World Cup Legacy Trust, including all expenses of the sales of the assets.
    2. Close the bank accounts to reflect a Nil Balance.
    3. Conclude the final audit of the Trust.
    4. Submit all the necessary documentation to satisfy the conditions as determined by the Master of the High Court for the complete dissolution of the Trust.
  - In the view of the report from the Legacy Trust to the NEC, the NEC decided as follows:
    1. That all SAFA trustees serving on SAFA Structures or involved in SAFA activities be withdrawn from the Trust ie. Dr Danny Jordaan, MS Ria Ledwaba, Mr Obakeng Molatedi and Mr Elvis Shishana.
    2. The NEC therefore appointed Mr Clive Grinaker to represent SAFA's interests during the dissolution period.
    3. The CEO must write to the trustees and thank them for their service and advise them of the decision of the NEC.
    4. The CEO must further write to FIFA to inform them as a partner of SAFA in the formation of the Trust.
    5. The CEO was also requested to write and inform Mr Clive Grinaker of the decision on the NEC.

The NEC unanimously adopted motion without an objection nor counter motion raised on a motion proposed by Mr Aubrey Baartman and seconded by Mr Tankiso Modipa.
